Precedence has been set that approval has to be granted before the city will reimburse a person for work done. Dockter motioned to deny this request and stay with its precedence. Ginny Weber was back to get clarification of the snow ordinance where it directly states that snow can't be moved from one street to another. Thomas stated that he thinks the ordinance is pretty clear. No action was taken.

Dockter motioned to give full time employees \$100 in Washburn Bucks and \$50 to part time employees. Simon seconded. Upon roll call, all members present voted aye. Motion carried.

AE2S Update:

The water supply project is still being looked at and other options that might be a possibility. Rainbow Energy is looking at possibly running 36' line out to the plant but that study won't be done until late 2023. The tech memo is still being worked on.

Street Improvement Project -30% design review meeting will be next week. The assessment district needs no action currently.
