

Ordinance No. 58

AN ORDINANCE GRANTING TO NORTH DAKOTA TELEPHONE COMPANY, A CORPORATION, ITS SUCCESSORS AND ASSIGNS, THE RIGHT TO USE AND OCCUPY THE STREETS, ALLEYS, AND OTHER PUBLIC PLACES OF _____, NORTH DAKOTA, FOR THE PURPOSE OF CONSTRUCTING, MAINTAINING AND OPERATING A GENERAL TELEPHONE AND TELEGRAPH SYSTEM WITHIN SAID CITY.

Be it ordained by the City Council of _____, North Dakota:

Section 1. That North Dakota Telephone Company, a corporation, its successors and assigns, are hereby granted the right to use and occupy the streets, alleys and other public places of the City of _____, North Dakota, for a term of twenty (20) years from the effective date hereof, for the purpose of constructing, maintaining and operating a general telephone and telegraph system within said City.

Section 2. That the rights herein granted are subject to the exercise of the police power as the same now is or may hereafter be conferred upon said City.

Section 3. That this ordinance shall be in full force and effect, and shall constitute a binding contract between the City of _____ and North Dakota Telephone Company when it shall have been enacted according to law, and when the provisions hereof shall have been accepted in writing by said North Dakota Telephone Company and such acceptance filed with the City Auditor.
