AN ORDINANCE TO AMEND AND RE-ENACT SECTION IX OF ORDINANCE NO. 99 RELATING TO LIMITATION OF HOURS AND DAYS OF SALE AT RETAIL OF BEER AND LIQUOR AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF:

BE IT ORDAINED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF WASHBURN, NORTH DAKOTA:

Amendment. Section IX of Ordinance NO. 99 is hereby amended and re-enacted to read as follows:

SECTION IX - LIMITATION OF HOURS AND DAYS OF SALE

No licensed pursuant to this ordinance shall sell, serve or permit to be sold, served or consumed on the premises named in the license any alcoholic beverage after one o'clock a. m. on Sundays, before eight o'clock a. m. on Mondays, or between the hours of one o'clock a. m. and eight o'clock a. m. on all other days of the week, Memorial Day, Good Friday, Thanksgiving Day, Christmas Day, or after six o'clock p.m. on Christmas Eve, or between the hours of one o'clock a.m. and eight o'clock p.m. on the day of any state wide, special, primary, or general election

PENALTY - Any person found guilty of violating any of the provisions of this ordinance shall be punished by a fine of not more than \$500.00 or by imprisonment for not to exceed 30 days or both such fine and imprisonment in the discretion of the Court.

No licensed pursuant to this ordinance shall sell, serve or permit to be sold, served or consumed on the premises named in the license any alcoholic beverage after one o'clock a.m. on Sunday, before eight o'clock a.m. on Mondays, or between the hours of one o'clock a.m. and eight o'clock a.m. on all other days of the week, Memorial Day, Good Friday, Thanksgiving Day, Christmas Day, or after six o'clock p.m. on Christmas Eve, or between the hours of one o'clock a.m. and eight o'clock p.m. on the day of any statewide, special, primary, or general election.

**PENALTY:** Any person found guilty of violating any of the provisions of this ordinance shall be punished by a fine of not more than \$500.00 or by imprisonment for not to exceed 30 days or both such fine and imprisonment in the discretion of the Court.


