

Ordinance #155

An ordinance establishing limitations and rules for the regulation of STOPPING, STANDING, OR PARKING RESTRICTIONS UPON THE CITY STREETS OF WASHBURN, ND.

Be it ordained by the City Commission of the City of Washburn, North Dakota:

1. This ordinance shall repeal and replace all other ordinances related to stopping, standing, or parking restrictions upon the city streets of Washburn, ND.
2. It shall be unlawful for anyone to park or leave standing on any street, avenue, highway, public ways, boulevards, or public property in the City of Washburn any vehicle, trailer, camper, boat, machinery, or other obstruction for a period longer than 72 hours except for Main Avenue and Seventh (7) Street which parking is limited to 24 hours.
3. It shall be unlawful for anyone to park or leave standing in any alley in the City of Washburn any vehicle, trailer, camper, boat, machinery, or other obstruction at any time except for the purpose of delivery, actively loading or unloading, utility work, or construction and maintenance purposes.
4. Any vehicle, trailer, boat, camper, etc. is only allowed to be parked in front of the owner's residence, so not to impede neighboring properties. It is strictly prohibited to have any camper slide-outs extending out into any part of a city street or avenue.
5. It shall be unlawful for anyone to park or leave standing on any street, avenue, highway, public ways, boulevards, public property, or alleys in the City of Washburn any trailer, camper, boat, machinery, or other obstruction from October 15th to April 15th so as not to interfere with fall and spring street cleaning and snow removal.
6. It shall be unlawful for anyone to park or leave standing on any street, avenue, highway, public ways, boulevards, public property, or alleys in the City of Washburn any vehicle or trailer which is unlicensed or for which the registration has expired.
7. Any businesses are not allowed to use any street, avenue, highway, public ways, boulevards, public property, or alleys in the City of Washburn to park or store their equipment unless in the active role of conducting business at the property involved.
8. It is unlawful to park or leave standing any vehicle, trailer, camper, boat, machinery, or other obstruction within ten (10) feet of a fire hydrant.
9. It shall be unlawful to park on snow emergency routes designated by the Washburn City Commission anytime four (4) or more inches of snow have fallen. Parking may resume once streets have been satisfactory cleared of snow.
10. Any person who is convicted of violating the provisions of this ordinance or of failing to comply with any of the provisions of this ordinance may be punished by a fine of fifty dollars (\$50.00), with the exception of #8 that is a state law punishable up to forty dollars (\$40.00), and any peace officer of jurisdiction is authorized to impound and remove any vehicle, trailer, boat, camper, etc. by order of the Washburn City Commission.

11. This ordinance shall be in full force and effect from and after its final passage and approval of the publication of its title and penalty clause.
