The meeting was called to order at 12:05 pm by President Donna Sommer.

- 1) Approval of the September 9th meeting minutes: Mark made a motion to approve the minutes with corrections. 2nd by Staci. **Approved**.
- 2) Financial Report: Staci reviewed the financial report as of October 14th. (Mark made a motion to approve the financial report as presented, 2nd by Donna) **Approved**.
- 3) Old Business:
 - a) **Board Position Appointment (Vacancy):** Donna let the board know that Rashel Crowell turned in her letter of resignation. Mark made a motion to approve of her request to step off board. 2nd by Staci. **Approved**.

- c) **Hwy 83 Billboards:** Donna led the discussion on the 8'x12' billboard. It has been ordered, received and waiting to be installed. Donna would like to go back to the city commission to apply for the lodging tax for future billboards.

Mark made a motion to purchase billboard border from Wagon Wheel at the expense of no more than \$200, 2nd by Donna. **Approved**

- d) **Light-up Washburn:** The committee has been trying to meet up with the community to decorate trees at Riverside Park. They will try to hang lights on Oct 19 (2-4pm). Discussion on lights.

- e) **2026 Budget:** The budget committee is still working on the budget. Discussion on the donation request letter to the American Legion Post #12.

- c) **Candy Caravan Update:** Staci gave an update on the event so far. There are 57 businesses signed up to participate so far. Staci will finish making phone calls this week.
- d) **Washburn Buck Promo:** Small Business Saturday promotion (Nov 29). Discussion on the event. Staci will talk to the Legion to see if they would like to participate again this year by donating money to help purchase Washburn Bucks.

- e) **Santa Day:** No Update. Mark made a note that we will be using the memorial hall for Santa Day.

- a) **Small Business Saturday Craft & Vendor Show (Nov 29):** Rhonda gave an update on the vendor show. There are 28 vendors/crafters signed up so far. The Washburn Park Board will be doing a fundraiser meal during the event.
- b) **Halloween Movie Night:** Rhonda is working with Kandi from the library along with the volunteers to host a movie and haunted hallway on Oct 31st at the memorial hall (movie-upstairs/haunted hallway-basement).
