


ORDINANCE NO. 107

AN ORDINANCE REPEALING ORDINANCE NO. 52 PROHIBITING THE MANUFACTURE, KEEPING AND SALE OF FIREWORKS, FIRECRACKERS, TOY PISTOLS AND AMMUNITION THEREFORE, AND GUNS OR EQUIPMENT USED FOR CREATING EXPLOSIONS BY THE USE OF CHEMICALS: AND PROHIBITING THE USE OF SUCH FIREWORKS, FIRECRACKERS, TOY PISTOLS AND AMMUNITION THEREFORE AND OF EQUIPMENT USED FOR CREATING EXPLOSIONS BY THE USE OF CHEMICALS WITHIN THE CORPORATE LIMITS OF THE CITY OF WASHBURN; PROVIDING PENALTIES FOR THE VIOLATION THEREOF:

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF WASHBURN, NORTH DAKOTA:

That Ordinance No. 52 entitled An Ordinance Prohibiting the Manufacture, Keeping and Sale of Fireworks, Firecrackers, Toy Pistols and Ammunition therefore, and Guns or Equipment used for Creating Expolsions by the use of Chemicals: and Prohibiting the use of such Fireworks, Firecrackers, Toy Pistols and Ammunition therefore and of Equipment used for Creating Explosions by the use of Chemicals within the Corporate Limits of the City of Washburn; Providing Penalties for the Violation thereof:is hereby repealed.


